

## Healthcare for the uninsured.

- ▶ Every patient connected to a low cost primary care medical home
- ▶ Members see primary care doctor an average of **2 to 3 visits per year** with a **\$15 copay**
- ▶ Comprehensive services provided at a direct cost of **\$367 per member**

- ▶ **50,000 patients** since began in 2002 with **5,069 served in FY18**
- ▶ **Average income** of clients is **\$12,293** with 83% of households working
- ▶ AD clients use the emergency room **36% less** than their uninsured peers
- ▶ **2,151 specialty care referrals** completed in FY2018

- ▶ 1 in 5 are living on annual income at or below the poverty line
- ▶ **Served 583 in CY2018** and 1,180 since program's inception
- ▶ Total premium is \$1,082

## A free pharmacy for uninsured.



- ▶ **Hundreds of medications** available at no cost to patients
- ▶ Commonly dispensed medications include those for the treatment of diabetes, asthma, hypertension, high cholesterol and mental illness
- ▶ **\$127,152 total cost savings in FY2018**
